Information we collect

We NEVER collect your credit card number or credit card expiry date or other details pertaining to your credit card on our SaaS platform. Credit card information will be obtained and processed by our online payment partner (HDFC payment gateway)

Other information. If you use our SaaS platform, we may collect information about your IP address and the browser you're using. We might look at what site you came from, duration of time spent on our SaaS platform, pages accessed or what site you visit when you leave us. We might also collect the type of mobile device you are using, or the version of the operating system your computer or device is running.

Feasibility Assessment: You consent to upload and sharing of protocol synopsis and feasibility questionnaires on our SaaS platform for the purpose of site feasibility assessment. The information provided will be used solely for assessing site feasibility and will not be shared with third parties without your explicit consent, except as required by law. All information provided by you will be treated as confidential and will only be accessible to authorized personnel, including our

employees and contractors, involved in the feasibility assessment process and to the sites that you have selected in our SaaS platform. The information will be retained only as long as necessary to fulfil the purposes outlined or as required by applicable law. We collect information in different ways

Use of your personal information
